The Direct Debit Guarantee

- If an error is made in the payment of your Direct Debit by The Queen's College or your Bank or Building Society you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund you are not entitled to, you must pay it back when The Queen's College asks you to.
- You can cancel a Direct Debit at any time by simply contacting your Bank or Building Society. Written confirmation may be required. Please also notify us.
