How and why can languages research contribute to current ARIs

The Areas of Research Interest (ARIs) reflect the interdisciplinary research needs of government organisations. Given its inherently interdisciplinary nature, languages research has much to contribute to both current and future ARIs. Languages research builds on language competence, societal and cultural knowledge, and interdisciplinary methods to address complex social issues. It draws on a range of perspectives and can provide narrative and historical evidence on individual lived experience, deriving general conclusions from individual cases.

Based on an analysis of current ARIs, here are broad areas where languages research can contribute:

- Community cohesion and communication.
- Disadvantaged communities.
- Access to public services.
- Participation in the cultural sector and public life.
- Multilingual underpinnings of social issues (e.g. crime, homelessness, modern slavery etc.).
- Integration and migration.

- Diplomacy, defence (language competence and cultural awareness).
- Cultural diplomacy.
- International trade.
- Economic growth.
- New technologies (including artificial intelligence).
- Devolution.
- Public health.

The word search for 'languages' on the Overton ARI database only yields a few results, but some key words or topics could potentially refer to languages in a more explicit manner, such as:

- 'Barriers' (e.g. to participation, to access to public services etc.) often include language barriers.
- Notions of 'support' and 'access' have a language dimension (e.g. language provision, access to employment, home and heritage languages etc.).
- Communication.
- Community and cohesion.
- List of factors (e.g. 'social, economic factors for...') could sometimes include **linguistic factors** as well.

The following table is a non-exhaustive list of concrete examples of how languages research can contribute to current ARIs and provides some simple alterations (in red) to current ARIs to make them more accessible to languages researchers.
